#### What are cookies?

Cookies are tiny text files stored on your computer when you visit certain web pages. Cookies enable us to 'know' if you have visited our site before, and recall some of the preferences you have set in past visits, in order that we may make your visit more productive. At Allflex dan-mark aps we use cookies primarily to keep track of what you have in your basket and to recall your account settings when you log in to your account.

Please note that cookies do not harm your computer and we do not store any personally identifiable information in the cookies we create.

We use a web analytics tool (Google Analytics) to analyse site usage in order to improve our website. The cookies set by Google Analytics collect data including, how our users arrive at our site, which pages they visit, what browser they are using and on what operating system etc. However, this analytics data does not contain any personally identifiable information.

If you choose to share Destron Fearing A/S web content with friends via social networks such as Facebook and Twitter, or access embedded video content on YouTube you may be sent cookies from these websites. We do not control the setting of these cookies, so please check the third-party websites for more information about their cookies and how to manage them.

Currently we operate an 'implied consent' policy which means that we assume you are happy with the usage of cookies on our website. If you do not want cookies to be set on your computer, you should either not use this site, delete Destron Fearing A/S cookies having visited the site, or browse the site using your browser's anonymous usage setting (called "Incognito" in Chrome, "InPrivate" for Internet Explorer, "Private Browsing" in Firefox and Safari.)

1. Allflex dan-mark aps, trading as Allflex dan-mark aps, complies with the principles of the GDPR Regulations and Data Protection Act 1998 when dealing with all data received from visitors to the site.
2. We only hold the data necessary to offer services related to the sale of products.
4. Data is only used for the purposes described in our entry on the Data Protection Register.
5. We only hold personal data for as long as necessary. Once data is no longer needed it is deleted from our files.
6. For administrative reasons data may be passed to and stored securely with third party service providers located outside the EEA (European Economic Area).
7. We occasionally email website news and information updates to those customers who have specifically subscribed to our email service. All subscription emails sent by us contain clear information on how to unsubscribe from our email service.
8. We never sell, rent or exchange mailing lists.
9. We may however share technical data with third party providers (such as Defra for tag registration purposes) to fulfil the customer contract. However, such information will also be subject to our partners' privacy policies.
